These schedules have been carefully developed to determine equitable levels for funding the programs of the Chamber.

Group I – General Industry

Made up of Manufacturers, Processors, Ag and Forestry Producers, Real Estate Agencies, Media, Hospitals, and any firm selling on a retail basis.
